Overview:

The Independent Citizens' Oversight Committee (ICOC) is a legally required committee appointed by the Board of Education to actively review the proper use of Prop. S, Prop. Z, Measure YY, and Measure U funds (hereafter "Bonds" or "Bond Funds"), and informs the public and the board regarding these expenditures. Bond Funds must be used for the projects listed in the bond language placed before the voters, and cannot be used for teacher or administrative salaries. The committee issues an annual report, which includes statements as to whether the district is in compliance with California Constitution Article XIII A, Section 1(b)(3) and results of its activities for the preceding year.

Commitment:

All members of the ICOC meet together monthly with District staff. In addition, each ICOC member is expected to participate in a subcommittee. Subcommittees meet as required by the subcommittee chairs. ICOC members are invited to Bond-related activities, such as visits to construction sites, and ground-breaking and ribbon-cutting ceremonies. ICOC members are expected to be prepared for all meetings.

Selection:

The ICOC is comprised of 119 volunteers appointed by the board after review and input from the Superintendent (or designee). To be considered for appointment, A an applicant must meet certain qualifications required by the California Education Code. In addition, the district has developed questions, the responses to which will be reviewed and scored by district staff, with a minimum score of 10 required to receive a recommendation for appointment.
